Seerha (Peace Be Upon Him): An In-Depth Article on Islamic Studies Exploring HEC-Approved Journals in Pakistan

Abstract

This paper offers an extensive examination of Islamic research journals approved by the Higher Education Commission (HEC) of Islamabad, with a particular focus on those published within Pakistani universities. It highlights the detailed introduction, prominent features, and core methodologies of these journals, with an emphasis on their contributions to scholarly discourse on Islamic teachings, especially the Prophetic Seerah (biography of the Prophet Muhammad, peace be upon him). Approved by the HEC, these journals are published in Urdu, Arabic, and English, reflecting their multidisciplinary nature. This study aims to elucidate the significant role these journals play in the academic exploration and dissemination of Islamic knowledge, positioning them as crucial platforms for fostering both traditional and contemporary Islamic scholarship. The analysis underlines the journals' pivotal role in enriching the understanding of Islamic teachings, influencing diverse academic and cultural landscapes in Pakistan.

Introduction

Academic journals serve as cornerstone platforms for the dissemination of research and scholarly thought, contributing significantly to the advancement of knowledge across various disciplines. In the context of Islamic studies, journals not only uphold the tradition of rigorous academic inquiry but also play a pivotal role in interpreting, preserving, and propagating the teachings and values of Islam. These publications are instrumental in fostering a deeper understanding of Islamic teachings, responding to contemporary issues, and bridging the gap between traditional scholarship and modern academic approaches. In Pakistan, the Higher Education Commission (HEC) has recognized the critical role of academic journals by endorsing a variety of publications that meet stringent quality and ethical standards. HEC-approved journals in Islamic studies are particularly noteworthy because they encapsulate a rich tapestry of multidisciplinary research that spans religious, cultural, social, and linguistic studies. These journals provide a platform not only for established scholars but also for emerging researchers to contribute to ongoing discussions and debates within the realm of Islamic scholarship.

The societal contributions of these journals extend beyond academia. They are instrumental in shaping public discourse on Islam, influencing educational curriculums, and providing insights that assist policymakers and community leaders in making informed decisions. By offering rigorous research and diverse perspectives, these journals help inculcate a well-rounded understanding of Islamic teachings, promoting tolerance, and intellectual engagement within and beyond Muslim communities. This article aims to explore the spectrum of HEC-approved Islamic studies journals in Pakistan, examining their development, their contribution to both the academic and societal landscapes, and the unique role they play in maintaining the dialogue between traditional Islamic teachings and contemporary academic challenges.

Through this examination, we gain insights into how these journals not only preserve but also illuminate the scholarly legacy of Islam, hence aptly earning the title "Scholars of the Light."

Al-Azva: A Trilingual Research Journal in Islamic Social Sciences

"Al-Azva," a research journal on Islamic social sciences, is published by the Sheikh Zayed Islamic Center at Punjab University, Lahore. This journal is among the few in the field of Islamic studies that have been recognized in the "Y" category by the Higher Education Commission (HEC), Islamabad. "Al-Azva" aims to publish content related to religious and contemporary Muslim world issues, although its issues often encompass articles on Qur'anic studies, Hadith sciences, Fiqh, the life of Prophet Muhammad (PBUH), history, Islamic economics, sociology, da'wah and guidance, research methodology, orientalism, comparative religion, and mysticism. Due to its diverse, research-based articles that address contemporary needs and issues, the journal has become a focal point for scholars' attention. All articles in this journal are presented with comprehensive references and citations, maintaining a scholarly and academic approach. The journal was first issued in October 1990 under the editorship of Dr. Zahoor Ahmad Azhar, initially exclusively in Arabic. Under the editorship of Dr. Jameela Shaukat,

starting from the second volume, the journal began to be published in both English and Arabic on a quarterly and later biannual basis. Dr. Khalid Alvi took over as the chief editor in September 1995. However, from issue number 7, volume 6 in 1996, Dr. Jameela Shaukat resumed the responsibility of editorship and continued to publish the journal for the next ten years. During her tenure, the content quality significantly improved, and articles started being published in Urdu, Arabic, and English. As Dr. Shaukat mentions in the introductions to volumes 13 and 14, issues 20 and 21: "Al-Azva" invites scholars to submit articles in Arabic, English, and Urdu that not only explore traditional topics but also reflect upon contemporary issues and requirements, aiming to disseminate their findings and thoughts to the seekers of knowledge."

In June 2002, under "Al-Azva," volume 12, issue 17, a special edition dedicated to the life of the Prophet Muhammad was published, consisting of 25 articles and spanning 334 pages. This issue featured articles from various Islamic thinkers, including Maulana Abu al-Hasan Nadwi's "The Ummah's Delegations in the Presence of the Prophet" and Dr. Muhammad Hamidullah's "Principles of Foreign Policy in the Prophetic Era."

By June 2006, in volume 17, issue 25, Dr. Abu al-Wafa Mahmoud took over as the editor. During his tenure, high-quality paper was used for printing, and the journal's title was made visually appealing. Dr. Mahmoud encouraged contributors to select diverse topics that went beyond traditional subjects, aiming to elevate the standards of the articles published. In June 2008, the editorship was handed over to Mr. Hafiz Mahmood Akhtar.

Since July 2009, the journal has been recognized by the Higher Education Commission of Islamabad in the "Y" category and elevated to the "X" category since March 2020. It holds the International Standard Serial Number (ISSN) 1995-7904, which is prominently displayed on both the interior and exterior covers of the publication. Articles featured in the journal begin with an English abstract spanning at least half a page and at most a full page. Citations and references for each article are meticulously documented in End Note format at the end of each piece. The editorial board includes the Vice-Chancellor among its eight international and three national members, supported by a seven-member Advisory Board. Currently, the journal is under the editorship of respected Dr. Muhammad Ejaz and Dr. Hafiz Abdul Qayyum. It can be accessed online at https://journal.aladwajournal.com/index.php/aladwa/about.

Al-Qalam³: A Scholarly Research Journal

This scholarly and research journal is published by the Department of Islamic Studies, University of Punjab, Lahore. It is a peer-reviewed journal that caters to national and international experts in Islamic studies and contemporary Islamic thought. The journal includes a variety of articles that cover different aspects of Islamic sciences such as Quranic studies, Hadith studies, Fiqh, the life of the Prophet, history, Orientalism, and preaching and guidance. Additionally, it features articles on global political and social contexts, the history of Pakistan, and Iqbaliyat (studies related to Allama Iqbal). The journal adheres to the standards and regulations set by the Higher Education Commission (HEC), ensuring high quality and maintaining a scholarly and research-oriented approach.

This research journal was initiated by Dr. Jamila Shaukat in February 1993. In reality, this journal is a continuation of the research journal 'Light of Islam' which was first published in 1966 by the Department of Islamic Studies and was initiated by Allama Alauddin Siddiqui. However, due to various unavoidable reasons, it could not continue for long. Consequently, Dr. Jamila Shaukat revived this project and resumed publication under the new title.

In the inaugural remarks of the journal "Al-Qalam," Dr. Jamila Shaukat highlights the consensus reached by the editorial staff on the name of the journal. She notes that the journal, initially published annually until June 2009 and subsequently on a semi-annual basis, will include articles in Urdu, the national language, as well as Arabic, the language of the Quran and the Prophet Muhammad (PBUH), and English to cater to contemporary requirements. The articles will cover significant topics such as the Quran, Hadith, Islam and Science, Education, and Economics. Dr. Shaukat mentions that research and innovation are critical functions of universities, and the publication of this journal by Punjab University is a valuable and significant addition to these efforts. She expresses her desire for the journal to attain high standards and to be recognized as a credible scholarly and research publication in Pakistan, with regular issuance maintained.

In line with the noble aspirations of Vice Chancellor Dr. Munir ud Din Chughtai and through the diligent efforts of its editors, the research journal "Al-Qalam" has progressively advanced. Initially comprising only 221 pages in its June 2009 volume, the journal expanded to 505 pages, reflecting significant growth. The finest paper was used for its printing, and the title was designed to be visually appealing.

Each issue of the journal features the first verse of Surah Al-Qalam on its title page: "Nun. By the pen and what they inscribe," which clarifies the reason behind the journal's name. The current editors, Professor Dr. Muhammad Hammad Lakhvi and Associate Editor Dr. Ehsan ur Rahman Ghauri, have elevated it to the highest standards of quality. The Higher Education Commission (HEC) included this journal in its list of approved journals in June 2009. Its International Standard Serial Number (ISSN) is 2071-8283, and it is abstracted and indexed by Index Islamicus.

The journal was initially approved in the "Y" category by the HEC in June 2009 and upgraded to the "X" category by March 2020. It includes English abstracts at the beginning of each article and detailed endnotes and references at the end. Detailed guidelines for contributors are provided in English on the official website of the journal, accessible at the following link: https://www.alqalamjournalpu.com/index.php/Al-Qalam. This ensures that the journal maintains a rigorous academic standard and serves as a valuable resource for researchers and academics.

"Jihat al-Islam" is an academic and research journal published by the Faculty of Islamic Studies at the University of Punjab, Lahore. This trilingual publication (Urdu, Arabic, and English) serves as the voice of the faculty, offering a platform for national and international experts to discuss various facets of Islamic studies. The journal's current editors are Professor Dr. Tahir H Basharat and Dr. Mohammad Abdullah. "Jihat al-Islam," which translates to "Dimensions of Islam," was aptly named to reflect the comprehensive representation of different Islamic sciences and arts. The inaugural issue was released in July 2007, and the publication continues to this day, approved by the Higher Education Commission (HEC) of Islamabad under the "X" category. Its ISSN is 1998-4472. The journal encompasses a board of 28 international and national professors and doctors and maintains a consultative panel of seven members. It also provides detailed guidelines for contributors under the section "A few requests from article writers."

"Jihat al-Islam" publishes articles across various disciplines including Quranic studies, Hadith, Islamic jurisprudence (Fiqh), Islamic history, the Prophet Muhammad's biography (Seerah), comparative religion, culture and civilization, Islamic economics, and more, in three languages. The special issue on the Seerah of the Prophet Muhammad (PBUH) (Volume 4, Issues 1-2) was awarded the Presidential Award by the Federal Ministry of Religious Affairs, Government of Pakistan, in January 2013. The contributors to this journal include distinguished scholars from Pakistan as well as from Egypt, India, Jordan, Saudi Arabia, Iraq, Bangladesh, Malaysia, and Africa. The journal also features a regular book review section, reviewing one or two books in each issue. Peshawar Islamics⁷: A Research Journal

The semi-annual research journal "Peshawar Islamics," organized under the auspices of Peshawar University and edited by Professor Dr. Muhammad Salim, was first published in 2010. Professor Dr. Qibla Ayaz refers to "Peshawar Islamics" as a continuation of JOSFISA, stating: "It is a matter of great pleasure that the first issue of 'Peshawar Islamics' is before you. This issue continues the legacy of the former journal of the Faculty of Islamic Studies & Arabic (JOSFISA), which was discontinued due to unavoidable reasons."

The journal has a patron-in-chief, a guardian, an associate editor, a 13-member editorial board, and a 6-member advisory council. The guardian of the journal outlines its primary objectives in the following terms:

"Our aim is to synthesize and advance the scholarly and interpretative efforts made so far in Islamic studies, to further develop this approach, and to conduct scholarly examinations of prevailing views on various topics and issues related to social sciences, particularly Islamic law, presenting alternative perspectives. This journal also provides an effective platform for intellectuals, scholars, and researchers who wish to disseminate their creative capabilities and intellectual prowess."

The journal under discussion is trilingual (Urdu, Arabic, English), with the Urdu section generally encompassing more pages. This journal was approved by the Higher Education Commission (HEC) of Islamabad in the "Y" category from February 2013 and has been included in the "X" category since December 2017. It carries the International Standard Serial Number (ISSN) 2305-154X, which is listed on the front cover of each issue. Suggestions for authors regarding the publication of articles are provided in both Urdu and English in each issue. Reviews of books and scholarly journals related to Islamic and Arabic studies are also published. The esteemed editor of Peshawar Islamics articulates the journal's standard, stating, "Our focus is on maintaining and enhancing the high standard of research. We do not want 'Peshawar Islamics' to be just another traditional research journal but aspire for it to be a benchmark in the field of knowledge and research, adorned with modern methodologies and topics. We continually urge our professors and research students to take up the pen and present scholarly and thoughtful solutions to unique contemporary issues from an Islamic perspective in a research-oriented manner."

Initially published exclusively in Arabic and renowned as an international Arabic journal, "Al-Idah" has since evolved into a trilingual publication. The founding editor and the Editor in Chief for its first ten issues was Professor Dr. Miraj ul Islam Zia. The journal is managed under a formal administrative body, editorial board, and an advisory council.

"Al-Idah" is a semi-annual scholarly and research journal published under the aegis of the Sheikh Zayed Islamic Center (SZIC), University of Peshawar. Despite experiencing various ups and downs and periods of inactivity, the journal has seen significant improvements in its standards and continuity of publication since coming under the stewardship of Professor Dr. Azmat Hayat Khan. Today, "Al-Idah" is noted for its attractive cover design and high-quality paper. The current patron of the journal is Professor Dr. Muhammad Rasul Jan, with Professor Dr. Rashad Ahmad Saljooq as the editor, and Dr. Muhammad Anwar as the deputy editor. The journal focuses on publishing high-quality research articles on crucial Islamic topics that are pertinent to contemporary needs. It has been recognized by the Higher Education Commission (HEC) of Islamabad, moving from category "Y" between October 2010 and August 2011 to category "X" since September 2011. The International Standard Serial Number (ISSN) for "Al-Idah" is 2075-0307, which is displayed on the journal's cover. The editor-in-chief, in an editorial, commends the HEC for setting high research standards and regulations that have significantly elevated the quality of research in Pakistan. "Al-Idah" strictly adheres to these guidelines, ensuring the selection and publication of articles align with the HEC's policies. Each article begins with an abstract in English, providing readers with a quick understanding of the article's objectives and content, and concludes with endnotes containing relevant references and citations. Fikr-o-Nazar¹²: The Oldest Scholarly and Research Journal of the Institute of Islamic Research

"Fikr-o-Nazar," the oldest scholarly and research journal of the Institute of Islamic Research at the International Islamic University in Islamabad, has been continuously published since August 1, 1963, corresponding to the 10th of Rabi-ul-Awwal, 1383 AH. Initially launched in Karachi and temporarily published from Rawalpindi, the journal's office was later moved to Faisal Mosque. The significance of this research journal is evident from the objectives outlined in its first issue, which emphasize a broad and rational interpretation of Islam in accordance with its fundamental principles.

- The journal is committed to elucidating Islam based on its fundamental principles, with a broad and rational perspective. It aims to clarify Islam's core objectives such as global brotherhood, tolerance, and social justice, among other matters.
- The journal aims to interpret Islamic teachings in a manner that highlights Islam's distinctiveness in the context of modern world's intellectual and scientific progress.
- It strives to research and document Islam's contributions to thought, science, and culture in such a way that Muslims can
 regain their eminent and superior position in these fields.
- The journal endeavors to foster organized and systematic research in Islamic history, philosophy, law, and principles of jurisprudence, promoting and advancing research, documentation, and scholarship in these areas.

consequently, the publication of the journal was initiated with these objectives in mind. As a result, the scope of "Fikr o Nazar" has been expanded to include publishing articles on a wide range of subjects from the perspectives of the Qur'anic sciences and Hadith, jurisprudence (Fiqh), theology (Kalam), and mysticism (Tasawwuf), to the history of Islam, education, teaching, philosophy, comparative religion, science, literature, economics, sociology, politics, culture and civilization, and the law and principles of law from an Islamic viewpoint. The journal supports freedom of expression within the bounds of Islamic limits, although the publication of an article does not necessarily imply that the institution agrees with the ideas and opinions presented therein. Each issue contains essential guidelines under the title "Instructions to Contributors" on the inside back cover, adherence to which is mandatory for the authors.

In the past, the editorial responsibilities of the journal "Fikr o Nazar" were handled by individuals such as Muhammad Sarwar, Abdul Rahman Tahir Surti, Dr. Sharafuddin Islahi, Dr. Aminullah, Rashid Ahmad Jalandhari, Muhammad Masood, Abdul Qudoos Hashmi, and Sahibzada Sajidur Rahman during different periods. Muhammad Saghir Masoomi, Mazharuddin Siddiqui, Dr. Abdul Waheed Halepota, and Mahmood Ahmad Ghazi also served as editors in various phases. Currently, the journal is edited by Professor Dr. Zia ul Haq and Assistant Editor Syed Mateen Ahmad Shah.

Over its 57-year history, the journal has published several special issues. Notably, Volume 36, Issue 3-4, June 1999, was a special publication on the study of the Quran in the Indian subcontinent, featuring 16 articles spanning 395 pages. Additionally, a special issue dedicated to Dr. Hamidullah was published in Volumes 40-41, from April to September 2003, highlighting various

aspects of his personality. Furthermore, two special issues have been published on the topic of the Prophet's biography, enriching the discourse on his life and teachings.

Since its inception in August 1963, the journal "Fikr o Nazar" was initially published monthly until Mahmood Ahmad Ghazi's tenure as editor, during which it became a quarterly publication. Ghazi significantly improved the scholarly and research standards of the journal. Subsequent editors, including Sahibzada Sajidur Rahman, continued to advance the journal's development. High-quality paper and an attractive, visually appealing title design have been used in its printing. In 2009, the Higher Education Commission (HEC) included it in its list of approved journals under the ISSN 4055-0430 in the "X" category, and since 2015, it has been included in the "Y" category, and in July 2019, it was moved to the "X" category.

Each article published in the journal begins with an English summary that spans a page, with citations and references noted at the bottom of each page in the form of footnotes. At the end of each issue, a detailed and useful Translation Table in English is provided, under the title "Table of Phonetic Effects/Transliteration for Urdu, Arabic, and Persian Terms", which assists authors in preparing English abstracts of their articles. The journal also publishes introductory advertisements and detailed reviews of new publications by the Islamic Research Institute (IRI). Recognizing its significance, the Ministry of Education, Government of Pakistan, has approved "Fikr o Nazar" for educational institutions and libraries, and IRI has also published an index of this research journal. This journal has published research articles on various topics related to the life of the Prophet Muhammad (PBUH).

The scholarly and research journal "Ma'arif Islami" has been published biannually since 2001 by the Faculty of Arabic and Islamic Studies at Allama Iqbal Open University, Islamabad. The Vice Chancellor of the university serves as the patron of the journal. The Chief Editor is Dr. Professor Ali Asghar Chishti, with Professor Dr. Abdul Hameed Khan Abbasi as the Editor, Professor Dr. Mohiuddin Hashmi overseeing the English section, Dr. Hafiz Muhammad Sajjad for Urdu, and Qari Muhammad Rafiq Sadiq for Arabic. This research journal encompasses articles in three languages: Urdu, Arabic, and English. The thematic scope of the published articles includes the Quranic sciences, Hadith, the biography of the Prophet, jurisprudence and its principles, theology, mysticism, comparative religion, Islamic history, education, notable Muslim figures, and Islamic topics, as well as book reviews and introductions. The journal also covers philosophy, science, literature, economics, sociology, politics, culture, and legal studies. Strict guidelines mandate that articles must include references and citations, and submissions without references will not be accepted.

Due to its high standards of research and significant academic contributions, the research journal was approved in December 2006 by the Higher Education Commission (HEC) under the "Y" category. Since March 2020, it has been included in the "X" category. The journal's International Standard Serial Number (ISSN) is 1992-8556. It features an editorial board and advisory board consisting of professors and high-profile academic and research personalities from both domestic and international spheres. The editor-in-chief writes the editorial under the title "Isharaat." Now, the selection and publication of articles adhere strictly to the policies set by the HEC. Unlike other journals that include English abstracts at the beginning of each Urdu and Arabic article, this journal writes its abstracts separately under the section titled "Abstracts," often dedicating its English section solely to these summaries. Each volume of the journal comprises two issues, and to date, numerous volumes have been published.

The journal "Maarif-e-Islami" has published a special edition titled "Seerat Number" in Volume 8, Issue 2, July 2009. Additionally, a special issue in memory of Dr. Mahmood Ahmad Ghazi was published under Volume 10, Issue 1. This issue, comprising approximately 480 pages and nineteen articles, chronicles the varied contributions of Mahmood Ghazi to academic journals and highlights his scholarly, political, and research efforts. The Islamic Culture¹⁸: A Rigorous Academic Semi-Annual Journal by the Sheikh Zayed Islamic Center, University of Karachi

"The Islamic Culture" is the official publication of the Sheikh Zayed Islamic Center (SZIC) at the University of Karachi, which has been in publication since 2004. Initially a quarterly journal, it transitioned to a semi-annual format in April 2012. The cover of each issue prominently displays the journal's name, followed by the phrase: "A rigorous academic semi-annual journal issued by the Sheikh Zayed Islamic Center, University of Karachi."

The journal under review has published more than 32 issues so far and features a 6-member editorial board and a 9-member advisory board. It is a trilingual publication presenting articles in Urdu, Arabic, and English, and publishes guidelines for authors. Each article is required to have an abstract that spans half to a full page, and, in line with other academic research journals, citations and references are provided at the end of each article. An index covering issues 1 to 20 has been compiled, encompassing a subject-wise, author-wise, and issue-wise summary spanning 34 pages.

The chief editor of the journal is Dr. Abida Parveen, while the editorial duties are performed by Dr. Muhammad Mehrban Barvi and Muhammad Irfan. In the past, scholarly figures such as Professor Dr. Khalil ur Rahman and Professor Dr. Noor Ahmad Shahtaz have been associated with the journal's editorial board. The journal has been approved by the Higher Education Commission (HEC) in category "Y" since March 2020. Its ISSN number is 1813-775X. The journal also published a special issue in 2007 titled "International Conference on Religious Tolerance and Harmony among Sects".
