In addition to influencing modern practices, this history provides a sense of continuity for practitioners who aim to establish a spiritual connection. The ruins of Buddhist architecture and art serve as reminders of this lasting influence, enhancing Kashmiri culture and laying the groundwork for future generations. Resilience and adaptability are also essential to Buddhism's continued applicability. The dynamism of the tradition is highlighted by the Buddhist teachings' capacity to coexist with regional norms and negotiate the challenges of contemporary life. This flexibility is essential for modern practitioners who deal with a variety of obstacles, indicating that traditional wisdom might provide insightful information about today's moral conundrums and intergroup disputes. This is particularly important in today's Kashmir, where communal violence makes societal cohesion more and more important. The results imply that encouraging communication and respect amongst various religious traditions can result in a more peaceful community and enhance the region's already rich cultural fabric

Furthermore, it is noted that Buddhist teachings contain ecological principles that are especially pertinent in light of the contemporary environmental issues. Buddhism is positioned as a guiding ideology for modern groups calling for ecological consciousness because of its emphasis on sustainability and mindful living. This link serves as an example of how traditional wisdom can influence contemporary behavior by providing frameworks for tackling urgent global concerns and encouraging moral

behavior.

Last but not least, the preservation of cultural legacy via artistic representations strengthens practitioners' feeling of identity and belonging by providing a crucial link to Buddhism's past. Rituals, festivals, and creative traditions that endure not only respect historical accounts but also fortify community ties in a time when these relationships are becoming more and more crucial. By fostering a sense of pride and resilience among practitioners, this cultural preservation makes sure that the rich tapestry of Buddhist legacy endures and is still relevant today. This study shows that the Buddhist heritage in contemporary Kashmir is a living, changing tradition that continues to influence identities and promote communal cohesiveness rather than just a historical artefact. Buddhism's enduring relevance is reinforced by the interaction of historical significance, adaptability, communal participation, environmental ethics, and cultural expression. Through an analysis of these themes, we are able to obtain a more nuanced picture of the place of Buddhism in modern-day Kashmiri society, emphasizing its capacity to help people overcome complicated current and future challenges. This comprehensive viewpoint not only deepens our understanding of Buddhism but also highlights how crucial it is to preserve its practices and teachings in order to provide direction in a world that is changing quickly.
