# A Review of Emotional Expression by Female Calligraphers in the Interior Design of Nvshu Yuan

#### Abstract

This study embarks on an exploration of the intricate world of Nvshu Yuan, an esteemed cultural gem deeply rooted in Chinese heritage. Within the elaborate strokes of this ancient script lies a concealed realm of emotional expressions, painstakingly crafted by female calligraphers. Nvshu, often referred to as "women's script," transcends the boundaries of mere linguistic significance, serving as a powerful conduit for women's aspirations of equality, independence, and self-esteem. While prior research has diligently scrutinized its linguistic and historical dimensions, this review directs its focus towards the concealed emotional dimensions ingeniously interwoven into its artistic representation. The systematic literature review in this study follows a comprehensive methodology, drawing inspiration from a rich tapestry of studies and scholarly contributions. This study aim to unravel the diverse creative styles and techniques employed by these adept female calligraphers to convey emotions, and in doing so, this study endeavours to establish thought-provoking parallels between the emotional resonances encapsulated within Nvshu and those found within the realm of traditional Chinese textual expressions. Beyond the realm of academia, the implications of our findings ripple into diverse facets of society. We explore the potential influence of Nvshu's emotional expressions on commercial practices, cultural heritage preservation, and the profound insights it offers within the context of feminist studies. This review aspires to illuminate the multifaceted dimensions of Nvshu Yuan's emotional expressions, enriching our understanding of women's profound cultural contributions and the enduring legacy they have bequeathed—a legacy resonating with emotions, aspirations, and enduring strength.

Over the ages, Nvshu has bestowed generations of women with a unique avenue for self-realization that transcends societal boundaries, leaving an indelible mark on the cultural landscape (Hillman & Radel, 2022). Intriguingly, within the extensive discourse surrounding Nvshu Yuan, one facet has remained concealed from scholarly scrutiny—the emotional symphony meticulously crafted by female calligraphers within the very essence of Nvshu Yuan's interior design (Wang, 2020). This review paper embarks on an intellectual odyssey to illuminate these concealed emotional dimensions, ingeniously curated by female calligraphers. Our dual objective is to discern the kaleidoscope of creative styles and techniques employed by these artists to convey emotions Wango (2022) and to establish insightful parallels between the emotional resonances encapsulated in Nvshu and those found within traditional Chinese textual expressions (He, 2022)

As we delve into this captivating exploration, we are guided by a multitude of studies and scholarly contributions that have paved the way for our research. To establish a robust foundation for our comprehensive review, this introductory section not only articulates the statement of the problem but also defines our research questions Melillo (2020), outlines our research objectives (Morgan et al., 2018), underscores the significance of our study (Shenton, 2022), and firmly establishes the scope of our inquiry (Miller, 2023). The statement of the problem positions our review within the context of prior scholarship Jenkins and Cahill (2023), showcasing a rich tapestry of research that spans the domains of linguistics, cultural studies, art history, and feminist studies (Jenkins & Cahill, 2023). ## Methodology


Our study employs a rigorous and comprehensive methodology similar to prior research but with a specific emphasis on examining the emotional expressions of female calligraphers in the context of Nvshu Yuan's interior design. The existing methodological approach is firmly grounded in well-established techniques within the academic field of art and cultural studies. Taherdoost (2023) emphasizes the significant role of doing comprehensive literature reviews to acquire a comprehensive comprehension of intricate subjects. The initial phase of our investigation involved doing a comprehensive examination of the academic literature to enhance our comprehension of the multifaceted emotional encounters exhibited by female practitioners of calligraphy. In our endeavour to

extract valuable insights, we have analyzed prior study endeavours that have delved into the creative realm of Nvshu Yuan. We utilized the available resources on the internet by doing an extensive search of key academic databases like Scopus, Web of Science, IEEExplore, and Google Scholar. Keller et al. (2022) stated that the databases were chosen based on their extensive coverage of several academic subfields and their inclusion of newly published, high-quality academic research. The search strategy employed in this inquiry was meticulously designed, incorporating certain keywords and phrases deemed crucial for the investigation's success. The aforementioned terms encompass concepts such as "the manifestation of emotions," "women engaged in the art of calligraphy," "the Nvshu Yuan script," and "the discipline of interior design." In addition to the prevalent method of doing keyword searches, we also employed the technique of document content analysis. This approach involves conducting a comprehensive study of textual materials to identify particular words, phrases, or concepts included within a compilation of documents. (Salih, 2022)

Meneses et al. (2019) assert that the utilization of this particular methodology facilitated a systematic categorization and quantification of the phenomenon under investigation, hence enabling a comprehensive exploration of the intricacies associated with the expression of emotions. Through our investigation, we have identified numerous distinct categories that have naturally developed as vital elements for comprehending the emotional expression embedded within Nvshu Yuan's interior design. The aforementioned categories comprised a wide range of aspects, which included examining the creative profiles of female calligraphers, doing a comparison analysis between Nvshu and conventional Chinese text usage, and exploring the broader implications of emotional expression. Our research transcended conventional boundaries, extending into fields such as commercial practices, cultural heritage, and feminist studies, highlighting the multifaceted nature of our investigation (Uygun, 2020). Our initial quest yielded a substantial pool of 1280 articles, reflecting the breadth and depth of scholarship in this domain. Subsequently, we implemented a rigorous screening process to identify the most pertinent studies, ultimately selecting 60 articles that met specific criteria: (Hamelink & Mahmoud, 2022)

- Employed qualitative and/or quantitative research methods.
- Sourced from peer-reviewed journals, ensuring the reliability and credibility of our chosen scholarship (Benlidayi, 2022).

#### Literature Review

Nvshu, often referred to as "women's script," is an extraordinary cultural phenomenon deeply rooted in the heritage of China (Ya-Ping et al., 2019). Originating in Jiangyong County, Hunan Province, this unique script captivates scholars and cultural enthusiasts alike. Nvshu, literally translated as "women's writing," encompasses a rich tapestry of linguistic, cultural, and historical significance (Ya-Ping et al., 2019). Ya-Ping et al. (2019) assert that the Nvshu script is a significant linguistic accomplishment, serving as a distinguishing feature that sets Nvshu apart from standard Chinese. The aforementioned writers' findings serve as the basis for this conclusion. The composition showcases elaborate characters, several of which have a design reminiscent of traditional Chinese needlework. Scholars in the fields of linguistics and philology have displayed a strong fascination with these characters, as they diligently endeavour to decipher the perplexing mysteries posed by this cryptic writing system (Ferrara, 2022). Nvshu holds great importance not only within the realm of linguistics but also within the intricate structure of Chinese society, particularly in areas where the nation's influence has experienced rapid growth and advancement in recent decades (Duan, 2022). According to Rungduin et al. (2022), this type of involvement offers unique perspectives on the lives, experiences, and goals of women.

Nvshu is a practice that serves as a means of expressing admiration for the resilience and determination displayed by women who, in the face of obstacles presented by a male-dominated societal structure, endeavoured to create an environment where their perspectives and lived realities could be acknowledged and comprehended (Ndongo, 2020). Nvshu serves as a means of expressing reverence towards women who successfully surmounted these obstacles and established a platform where their perspectives could be acknowledged and comprehended. Nvshu serves as an emblematic representation of the unwavering determination and aspirations of women in their pursuit of personal accomplishments. The juxtaposition of modern and old elements in Nyshu presents distinct offerings for tourists to the city. The aforementioned pattern, observed in many periods of Chinese history by Muhametzyanov et al. (2019), may be traced back to the Ming and Qing dynasties (1368-1912), serving as a testament to the resilience exhibited by women in China. This phenomenon has persisted over a significant period, and its beginnings can be attributed to diverse temporal and geographical contexts. Niazi (2023) suggests that Nvshu played a dual role during this specific era, both as a medium of communication and providing emotional solace for women, particularly those from economically disadvantaged backgrounds. Denzongpa and Nichols (2020) assert that Nyshu has persevered as a representation of women's resilience, independence, and self-esteem, despite the limitations imposed by societal and historical factors.

As asserted by Ros i Sole et al. (2020), the aforementioned statement exemplifies the remarkable capacity of the human spirit to overcome challenges and cultivate a diverse cultural legacy. Estenson (2019) asserts that scholars and enthusiasts of gender studies, linguistics, and Chinese culture maintain the ongoing relevance of Nvshu. The enduring impact of this phenomenon endures as a wellspring of motivation, commemorating the fortitude and ingenuity of women who challenged prevailing cultural limitations to construct their distinctive personal stories (Hu et al., 2020). The Nvshu script is a notable cultural fabric, characterized by its linguistic, cultural, and historical importance. The complex and nuanced characters inside this narrative depict the experiences of women across different periods, as they endeavour to articulate their feelings, aspirations, and sense of self. The lasting impact of Nvshu stands as evidence of the significant role that culture and language play in defining and safeguarding the stories of marginalized communities.

The art of calligraphy in Nvshu Yuan, a captivating domain, is skillfully employed by female practitioners to express a rich tapestry of emotions. However, it is crucial to note that this specific aspect has not been extensively examined in the academic literature (Mateescu, 2020). According to Wang and Chen (2020), the authors assert that Nvshu calligraphy possesses a transformative quality that extends beyond its utilitarian purpose, and instead emerges as a profound medium for conveying emotions. According to prevailing discourse, this assertion is made on the basis that art transcends its utilitarian function. Liu and Yin (2020) assert that the women at Nvshu Yuan demonstrated good communication skills by methodically crafting characters and strokes to convey a diverse array of feelings. This facilitated the effective expression of their ideas and emotions. The creative manifestation resonated with the myriad of experiences, challenges, and ambitions that women have encountered throughout human history. Fatima (2021) asserts that the utilization of characters in Nvshu extends beyond their literal interpretations, hence facilitating the articulation of a diverse array of subtle emotions. Pan et al. (2020) conducted a study which suggests that the brushstrokes found in these artistic pieces possess significant implications, effectively communicating a wide spectrum of emotions that vary from nuanced to explicit.

In essence, the brushstrokes evident in these artistic creations manifest as purposeful and fervent conduits of emotional expression. The brushstrokes employed in these artworks effectively convey the sensory experiences and cognitive processes of the women responsible for their creations. To get a thorough grasp of the profound emotional intricacies inherent in Nvshu calligraphy Pan et al. (2020), it is imperative to possess a profound comprehension of the historical and cultural milieu from which it sprang. Acquiring a comprehensive comprehension of the vast emotional intricacies encapsulated within Nvshu calligraphy necessitates the undertaking of this endeavour. To attain a comprehensive understanding of a concept or phenomenon, it is important to possess the ability to recreate the historical and cultural context in which it initially originated. According to Zhou et al. (2022), within a social context where women's voices are often suppressed, this platform provides an avenue for women to express their deepest thoughts and emotions. This was achievable notwithstanding the prevalent suppression of women's voices. The emotional experiences of these women encompassed a wide range, spanning from positive affective states such as joy and love to negative emotional responses including grief and resilience. Positive emotions like as joy and love coexisted alongside negative emotions such as resilience and grief. The diversity of emotions observed in individuals can be attributed to the diverse and complex aspects of their lives, as noted by Hoemann et al. (2023).

Ithough researchers have extensively examined the language and historical elements of Nvshu, there is a dearth of exploration into the emotional nuances embedded within the strokes of Nvshu calligraphy (Rao & Zheng, 2021). The artistic representation under examination reveals a plethora of emotions, offering valuable insights into the intricate emotional terrain of women's experiences in ancient China (Wu, 2021). The interpretation of the emotional complexities embedded in Nvshu calligraphy necessitates a nuanced approach (Yuan et al., 2021). To fully comprehend the characters, it is essential to possess knowledge not only of their traits but also of the cultural and historical milieu within which they were conceived (Pan et al., 2020). The emotional resonance present in these artworks is influenced by various factors, including the strokes, spacing, and arrangement of letters. In essence, Nvshu calligraphy stands as a testament to the emotional richness of women's lives in historical China. These elements collectively tell a story of the women's inner worlds and their desire for self-expression (Mozeley et al., 2023). As one navigates through Nvshu Yuan, the spatial configuration subtly guides visitors on an emotional journey (Wang et al., 2023). Spaces designed for contemplation evoke a sense of introspection and self-discovery, while communal areas foster a feeling of unity and shared experiences. Each nook and cranny of Nvshu Yuan is a canvas of emotions.

One of the most intriguing aspects of Nvshu Yuan's emotional design is its use of silence (Yuan, 2021). The intentional creation of spaces where silence prevails allows for introspection and personal connection with the emotions embedded in its design. Silence, in this context, is not the absence of sound but the presence of a profound emotional experience. While Nvshu calligraphy itself is an expressive art form, the emotional dimensions of its architectural surroundings have often been overlooked in favour of linguistic and historical analyses (Jian & Nicolas, 2021). Our research seeks to restore these emotional legacies, highlighting their significance in understanding the resilience and aspirations of women in historical China. The emotional dimensions concealed within the interior design of Nvshu Yuan are a testament to the intricate artistry of female calligraphers and architects who wove their feelings, experiences, and dreams into the very fabric of the sanctuary. This overlooked aspect of Nvshu Yuan's cultural heritage enriches our understanding of the emotional tapestry of women's lives in a bygone era.

Our research acknowledges and commends this process of empowerment. The mere presence of Nvshu poses a direct challenge to the prevailing patriarchal systems that were in place during its era. According to Shah and Riaz (2022), women challenged the prevailing male-dominated standards of the time by employing a distinctive script as a means of expressing their thoughts and emotions. The aforementioned demonstration of resistance and self-expression serves as a monument to the fortitude exhibited by women.

The emphasis on emotional expressiveness in Nvshu is particularly notable when viewed through a feminist lens. In a societal context characterized by the frequent silencing and marginalization of women, Nvshu emerged as a valuable medium through which women could express their experiences, emotions, and aspirations (Palaniswamy et al., 2019). The act of expressing emotions in this context might be interpreted as a means of protesting against the systemic oppression that is based on gender. The reason for this is that Nvshu serves as a representation of female empowerment. According to Allotey and Denton (2020), This statement underscores the need to safeguard and commemorate the achievements made by women to culture and society.. the feminist perspective of our research on Nvshu Yuan's architectural design underscores the significance of women's agency, empowerment, and emotional expression. It highlights the subversive nature of Nvshu in challenging patriarchal norms and serves as a link between historical and contemporary feminist movements. By acknowledging and celebrating Nvshu as a cultural and feminist legacy, we contribute to a deeper understanding of women's roles in history and society. Furthermore, our investigation has revealed significant similarities between the emotional implications conveyed through Nvshu and those present in conventional Chinese written forms. Similar to the art of writing on parchment, the interior design of Nvshu conveys feelings that possess lasting cultural importance.
